#### National Ayush Mission (NAM) scheme

#### 641 Shri P. Wilson:

Will the Minister of *Ayush* be pleased to state:

(a) the funds allotted and disbursed under National AYUSH Mission (NAM) scheme across the country including Tamil Nadu;

(b) the present status regarding the establishment of AYUSH health care services, AYUSH Health the Wellness Centres and accessible helpline under NAM scheme; and

(c) the funds allotted for Ayurveda, Yoga & Naturopathy, Unani and Siddha research programmes across the country especially in Tamil Nadu and the details thereof?

## ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) The funds allotted/disbursed/central share released under Centrally Sponsored Scheme of National AYUSH Mission (NAM) scheme across the country including Tamil Nadu is furnished at **Annexure-I**.

(b) Public Health being a State subject, establishment of AYUSH health care services and AYUSH Health the Wellness Centres comes under the purview of respective State/UT Governments. However, under Centrally Sponsored Scheme of National AYUSH Mission (NAM), there is a provision of financial assistance for setting up of 10/30/50 bedded integrated AYUSH Hospital and construction of building to establish new AYUSH dispensary in the area where there are no AYUSH facilities available. Further, under NAM, as per the provision of guidelines, the Healthcare facilities to be upgraded as AYUSH Health and Wellness Centre are AYUSH Dispensaries and AYUSH Sub-Centers. As per the proposal received from State/UT Government, status of integrated AYUSH Hospital and AYUSH Health the Wellness Centres approved under

NAM is furnished at **Annexure-II.** However, there is no provision of helpline under NAM scheme.

(c) Central Council for Research in Ayurvedic Sciences (CCRAS), Central Council for Research in Unani Medicine (CCRUM), Central Council for Research in Siddha (CCRS) and Central Council for Research in Yoga & Naturopathy (CCRYN) are autonomous organizations under Ministry of Ayush for research in Ayurveda, Unani, Siddha and Yoga & Naturopathy respectively and these councils are conducting different research activities through their peripheral institutes available in different parts of the country. CCRAS, CCRUM, CCRYN and CCRS are working towards the scientific validation in the concerned system of medicines through clinical research, drug research, medicinal plants research, fundamental research, literary research and documentation. However, under NAM, there is no provision of Ayurveda, Yoga & Naturopathy, Unani and Siddha research programmes across the country including in Tamil Nadu.

# "FDI in Ayurveda drug industry"

#### 642 Smt. Jebi Mather Hisham:

Will the Minister of *Ayush* be pleased to state:

(a) the number of herbal drug companies that have obtained the mandatory Good Manufacturing Practices (GMP) certification as laid down by WHO, State-wise and company-wise; (b) the details of steps taken to ensure high quality and to maintain international standards of Ayurveda medicines amid concerns that majority of Ayurvedic drug makers in the country have quality issues;

(c) whether Government will establish Government-owned state-of-the-art testing facilities for Ayurveda drugs in every State to ensure the prescribed quality standards; and(d) whether Government has planned to attract FDI in the Ayurveda drug industry, taking into account the massive potential for exponential growth, if so, the details thereof?

#### ANSWER

# THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) Sir. As prescribed in Drugs and Cosmetics Act 1940 and Rules 1945 made thereunder, enforcement of the legal provisions pertaining to Quality Control and issuance of drug license of Ayurveda, Siddha, Unani and Homoeopathic drugs, is vested with the State drug Controllers/ State Licensing Authorities appointed by the concerned State/ Union Territory Government. Rule 158-B in the Drugs and Cosmetics Rules, 1945 provides the regulatory guidelines for issue of license to manufacture Ayurvedic, Siddha, Unani medicines and Rule 85 (A to I) in the Drugs and Cosmetics Rules, 1945 provides the regulatory guidelines for issue of license to manufacture Homoeopathic medicines. It is mandatory for the manufacturers to adhere to the prescribed requirements for licensing of manufacturing units & medicines including proof of safety & effectiveness, compliance with the Good Manufacturing Practices (GMP) as per Schedule T & Schedule M-I of Drugs and Cosmetics Rules, 1945 and quality standards of drugs given in the respective pharmacopoeia.

(b) The steps taken by Ministry of Ayush and State/UTs government to ensure high quality and to maintain international standards of Ayurveda medicines are as follows –

 Ministry of Ayush has implemented Central Sector Scheme AYUSH Oushadhi Gunvatta Evam Uttpadan Samvardhan Yojana (AOGUSY) with financial allocation of Rs 122.00 crores for five years. The components of the Scheme are as under;

A. Strengthening and up-gradation of Ayush Pharmacies and Drug Testing Laboratories to achieve higher standards.

B. Pharmacovigilance of ASU&H drugs including surveillance of misleading advertisements.

C. Strengthening of Central and State regulatory frameworks including Technical Human Resource & Capacity Building programs for Ayush drugs.

D. Support for development of standards and accreditation/ certification of Ayush products & materials in collaboration with Bureau of Indian Standards (BIS), Quality

Control of India (QCI) and other relevant scientific institutions and industrial R&D centres.

- For facilitating exports, Ministry of Ayush encourages following certifications of AYUSH products as per details below:-
- i. Certification of Pharmaceutical Products (CoPP) as per WHO Guidelines for herbal products.
- ii. Quality Certifications Scheme implemented by the Quality Council of India (QCI) for grant of AYUSH Premium mark to Ayurvedic, Siddha and Unani products on the basis of third party evaluation of quality in accordance with the status of compliance to international standards.
- Ministry of Ayush has setup Pharmacopoiea Commission of Indian Medicines & Homoeopathy (PCIM&H), Ghaziabad to lay down Pharamcopoeial Standards and Formulary specifications for Ayurveda, Siddha, Unani and Homoeopathy drugs, which serves as official compendia for ascertaining the identity, purity and strength of the drugs included therein. In 2021, Pharmacopoeia Commission for Indian Medicine & Homoeopathy (PCIM&H), Ghaziabad a sub-ordinate office of Ministry of Ayush has signed a MoU with American Herbal Pharmacopeia, USA for developing standards of Ayurveda and other Indian systems of medicine on international standards. Further, PCIM&H has taken up the task to harmonize all the monographs published/ being published through Ayurvedic Pharmacopoeia of India (API), Siddha Pharmacopoeia of India (SPI), Unani Pharmacopoeia of India (UPI), Homoeopathic Pharmacopoeia of India (HPI) and Indian Pharmacopoeia (IP). PCIM&H and Indian Pharmacopoeia Commission (IPC) have signed a MoU for developing "ONE HERB ONE STANDARD".
- Pharmacovigilance Centres for Ayurveda, Siddha, Unani and Homoeopathy (ASU&H)
   Drugs set up in different parts of the country under the Central Scheme of Ministry of
   Ayush are mandated to monitor and report the misleading advertisements to the

respective State Regulatory Authorities. A three tier structure comprising of a National Pharmacovigilance Co-ordination Centre (NPvCC), Intermediary Pharmacovigilance Centres (IPvCs) and Peripheral Pharmacovigilance Centres (PPvCs) is established. All India Institute of Ayurveda (AIIA), New Delhi under Ministry of Ayush is the National Pharmacovigilance Co-ordination Centre (NPvCC) for the implementation of the National Pharmacovigilance program for Ayurveda, Siddha, Unani & Homoeopathy drugs. Objectionable advertisements are being reported to the respective State Licensing Authorities by PPvC at regular intervals.

(c) Sir. 27 State Drug Testing Laboratories have been supported for strengthening their infrastructural and functional capacity. As on date, 81 laboratories are approved or licensed under the provisions of Drugs and Cosmetics Rules, 1945 for quality testing of Ayurvedic, Siddha and Unani drugs and raw materials. Central Council for Research in Ayurvedic Sciences (CCRAS) under Ministry of Ayush has 01 Drug Testing Laboratory at Captain Srinivasa Murthy Central Ayurveda Research Institute (CSMCARI), Chennai.

(d) Yes Sir. Ministry of Ayush has organized a three day Global Ayush Investment and Innovation Summit (GAIIS) from 20 -22 April, 2022 at Mahatma Mandir, Gandhinagar, Gujarat. The Global Ayush investment and Innovation Summit, 2022 was a distinctive effort by the Government of India to attract the world's attention to India's ancient wisdom and traditional knowledge, and capitalize on it to pave the way for a sustainable future. The Summit was organized in line with Sustainable Development Goal Number 3 of promoting "Good Health and Well-being."A total of five plenary sessions, eight roundtables, six workshops, and two symposiums were organized and 90 eminent speakers and 100 exhibitors participated during GAIIS.

Ministry of Ayush, Government of India in consultation with Department of Commerce has supported to establish Ayush Export Promotion Council (Ayushexcil) to promote the export of Ayurveda products/ medicines as well as Ayurveda services. This was launched by the Hon'ble Prime Minister on 20<sup>th</sup> April 2022 at Global Ayush Innovation and Investment Summit in Gandhinagar (Gujarat).

As informed by Union Territory of Puducherry, Government of Puducherry informed that Department of Drugs Control, Govt. of Puducherry has organized an investor's meet on 07.03.2022 jointly with the Puducherry Drug manufacturers Association in the presence of Hon'ble Chief Minister, Secretary (Health), other officials and associations.

#### **Standardisation of quality of Ayurvedic medicines**

## 643 Dr. Sudhanshu Trivedi:

Will the Minister of *Ayush* be pleased to state:

(a) whether it is a fact that, during the first wave of COVID-19 pandemic in the country, the Union Government officially accepted and suggested the use of Homoeopathic and Ayurvedic medicines; and

(b) the measures being taken by Government for standardisation of the quality of Ayurvedic medicines as some times this becomes the biggest impediment in using them particularly in Ras and Bhasma?

# ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) Yes Sir. The steps taken by Ministry of Ayush in the mitigation and management of COVID-19 through Ayurveda and Homoeopathy systems of medicines are at Annexure-I. Pharmacopeia Commission of Indian Medicine & Homoeopathy (PCIM&H), a subordinate office of Ministry of Ayush published the standalone formulary specifications and Pharmacopoeial monographs of Ayush Kwath Curna/ Ayush Kutiner Curnam/Ayush Sufuf-e Joshanda for Ayurvedic, Siddha, Unani medicine respectively.

(b) Ministry of Ayush has setup Pharmacopeia Commission of Indian Medicine & Homoeopathy (PCIM&H), Ghaziabad to lay down Pharmacopoeial Quality Standards and Formulary specifications for Ayurveda, Siddha, Unani & Homoeopathy (ASU&H) drugs, which serve as official compendia for ascertaining the identity, purity and strength of the drugs included therein and the standards mentioned therein are mandatory. Till date, 665 quality standards [in Ayurvedic Pharmacopeia of India (API) Part I- Vol. I to X] on raw materials (Single Drugs of plant/animal/Mineral/metal origin), 203 Pharmacopoeial monographs (in API Part II- Vol. I to IV and 01 standalone pharmacopoeial standards) and also 1036 Formulary specifications [in API Part I-IV, 01 standalone formulary specification] had been published in Ayurvedic Pharmacopoeias/Formularies. In addition to this, supporting documents in the form of Macro-Microscopic & TLC Atlas on 351 single drugs incorporated in API also published. The said pharmacopoeial monographs includes 41 quality standards on various raw materials of mineral/metal origin (in API Part I, Vol. VII & Vol. X), and also various formulary specifications of Ayurvedic medicines containing Ras and Bhasmas as an ingredient are included under dosage forms like Vatis, Bhasmas, Ras, Kupipakwa Rasayana, Lauh Mandoor etc. have been prescribed in different parts of Ayurvedic Formulary of India (AFI).

Central Council for Research in Ayurvedic Sciences (C.C.R.A.S.) under Ministry of Ayush has also developed quality parameters and generated evidence on safety of 14 Bhasma & Rasoushadhi and published in the form of technical reports.

# Annexure-I

- 25. Ministry of Ayush issued an advisory on how to protect yourself from COVID and how to stay healthy. In the advisory, in addition to maintaining hygiene like hand wash, use of mask etc. simple home remedies were also suggested for people.
- 26. A letter to all Chief Secretaries of States / Union territories was sent from the Ministry with more specific suggestions on augmentation of General Immunity of people and about possible AYUSH intervention wherever required in coordination with Health departments of the States/UTs.
- 27. Ministry has sent a D.O. letter to Principal's of all Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) colleges (approximately 727 colleges) for utilization of available infrastructure facilities like Hospital (IPD & OPD), pathology laboratory, ICU and manpower including medical & Paramedical Staff to combat with the COVID-19 pandemic. Therefore, they were requested to offer their services to local health authorities for utilization of the available facilities by them as per the situation arises. Accordingly, the various AYUSH institutes hospital were utilized by State Governments and designated as quarantine centre, isolation centre, Covid care centre and Covid health centre.
- 28. Ministry of Ayush recommends self-care guidelines for preventive health measures and boosting immunity.
  - General Measures
  - Ayurvedic Immunity Promoting Measures
  - Simple Ayurvedic Procedures
  - During dry cough/sore throat
- 29. The Ministry of Ayush had launched a three-month campaign on "Ayush for Immunity", through webinar and also publishing campaign bulletin on AYUSH for Immunity. More than 50 thousand people participated in the Webinar.
- 30. Ministry of Ayush has formed an Inter-disciplinary AYUSH R&D Task Force chaired by Prof. Bhushan Patwardhan and having representation from scientists including Indian Council of Medical Research (ICMR), Department of Biotechnology (DBT), Council of Scientific and Industrial Research (CSIR), All India Institute of Medical Sciences (AIIMS) and Ayush Institutions. The Interdisciplinary AYUSH Research and Development Task Force has formulated and designed clinical research protocols for prophylactic studies and add-on interventions in COVID-19 positive cases through thorough review and consultative process of experts of high

repute from different organizations across the country for studying four different interventions viz. *Ashwagandha, Yashtimadhu, Guduchi + Pippali* and a poly herbal formulation (AYUSH-64).

31. Ministry of Ayush issued Gazette notification for undertaking research on COVID-19 through Ayurveda, Siddha, Unani and Homeopathy Systems including prophylactic measures, intervention during the quarantine, asymptomatic and symptomatic cases of COVID-19, Public Health Research, Survey, Lab Based Research etc. to generate evidence.

Ministry of Ayush has also launched interdisciplinary studies involving AYUSH interventions for COVID-19 based on recommendations of Task force. Under various research organizations and National Institutes under Ministry of Ayush, 150 research studies in the country are being conducted on AYUSH interventions.

- 32. Guidelines for Registered Practitioners of respective system of Ayush including Ayurveda & Homoeopathy, have been prepared by Director Generals of Research Councils and Directors of National Institutes with their team of experts and same is vetted by the Interdisciplinary AYUSH Research and Development Task Force of Ministry of Ayush. These guidelines are made available in public domain for the benefit of registered AYUSH practitioners including Ayurveda & Homoeopathy to help in the management of COVID 19 pandemic uniformly.
- 33. Government of India has also released "National Clinical Management Protocol based on Ayurveda and Yoga for management of COVID-19" prepared by National Task force.
- 34. Ministry of Ayush has also released Ayurveda, Unani and Siddha preventive measures for selfcare during COVID-19 and Guidelines for Ayush Practitioners for COVID-19 Patients in Home Isolation.
- 35. During COVID-19 pandemic, AYUSH-64 and Kabasura Kudineer has emerged as a ray of hope for the patients of mild and moderate COVID-19 infection. The scientists of reputed research institutions of the country have found that AYUSH 64, a poly herbal formulation developed by the Central Council for Research in Ayurvedic Sciences (CCRAS), Ministry of Ayush is useful in the treatment of asymptomatic, mild and moderate COVID-19 infection as an adjunct to standard care.
- 36. In order to provide maximum benefit of Ayush systems of medicine, a Nation-wide campaign for distribution of AYUSH-64 and Kabasura Kudineer through 86 clinical units of Research Councils and National Institute under Ministry of Ayush across the country, has been launched.

- 37. Ministry of Ayush has also issued advisory for Ayush practitioners on ethical practices during COVID- 19 pandemic.
- 38. Ministry of Ayush has released Home care guidelines for children and Advisory for AYUSH Practitioners about prophylactic care in Children during the COVID-19 Pandemic.
- 39. Ministry of Ayush has released information for Ayurveda Practitioners for Prophylactic, Symptomatic Management of suspected and diagnosed cases of Mucormycosis.
- 40. Ministry of Ayush has also released Ayush recommendations for the public on holistic health and well-being Preventive measures and care during COVID-19 & LONG COVID-19.
- 41. Ministry of Ayush has released guidelines for Ayurveda Practitioners for COVID-19 patients in Home Isolation and Ayurveda Preventive Measures for self care during COVID-19 Pandemic.
- 42. Ministry of Ayush has released an advisory on Ayush interventions for Prophylaxis & Management of COVID-19 and Ayush guidelines for COVID-19 cases for care givers.

# 644. DR. SUDHANSHU TRIVEDI:

Will the **Minister of Ayush** be pleased to state:

(a) the present status of activities being undertaken in the WHO Global Centre for Traditional Medicine (GCTM) in Jamnagar, Gujarat?

# ANSWER

## THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) WHO-GCTM is an outpost centre of WHO-HQ (Geneva) funded by the Government of India. It will help establishing strong linkages among the Member States of WHO. The WHO-GCTM would emerge as a centre of global wellness which will promote the development of medicines and research related to Traditional Medicines and will strengthen evidence-based research, training and awareness about Traditional Medicines.

The activities/scope of work of the WHO-GCTM is as follows:

- xv. To act as a mentor for the development and shaping health research agenda, setting international norms and standards, providing technical support to countries, and monitoring & assessing health trends of traditional medicine.
- xvi. To establish research methodology standards and develop standards for clinical practice and protocols in traditional medicine.
- xvii. To ensure quality, safety and efficacy, accessibility and rational use of traditional medicine.
- xviii. To develop norms, standards, and guidelines in relevant technical areas, tools and methodologies for collecting data, undertaking analytics and assess impact.
- xix. To build partnerships and collaborations within WHO, and special programs (IARC, WHO Academy, TDR, Alliance for Health Policy Research, Special program on PHC), other UN agencies, WHO collaborative centre networks, international organizations and professional associations, and objective-specific advocacy groups, in areas of relevance to the objectives.
- xx. To develop specific capacity building and training programs in the areas of relevance to the objectives and conduct training programs in campus, residential, or web-based, and through partnerships with the WHO Academy and other strategic partners.
- xxi. To act as a guiding principle in developing guidelines for health technology assessment and health economics inferred from traditional medicine and support countries' evolving strategies on this.

#### 645 # SHRI B. LINGAIAH YADAV:

Will the Ministry of AYUSH be pleased to state:

- (a) whether it is a fact that office-bearers of National Commission for Homoeopathy (NCH) are from private institutions or autonomous bodies and many of them are with little or no experience of policy making at national level;
- (b) whether it is also a fact that NCH has no representation of women even though 70 per cent of Homoeopathy students are women; and
- (c) whether Government would consider appointing some more senior level Central Government officers, especially women, from the cadre of Ministry of Ayush / GDMO (AYUSH/ CHS/CGHS) to NCH since they are screened and selected through rigorous process by UPSC?

# ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) Office bearers of National Commission for Homoeopathy are recruited as per the provisions of NCH Act, 2020 and are from all sectors including Government Organization/Autonomous bodies as well as from Private Institutions.

All the office-bearers of NCH are possessing qualifications and experience as prescribed in NCH Act, 2020 for the respective posts. The prescribed qualifications for Chairperson of the Commission is postgraduate degree in Homoeopathy from a recognized University with experience of not less than twenty years in the field of Homoeopathy, out of which at least ten years shall be as a leader in the area of healthcare delivery, growth and development of Homoeopathy or its education. However, the prescribed qualification for President and Members of the Autonomous Boards of NCH is post-graduate degree in respective disciplines from a recognized University with experience of not less than fifteen years in respective fields, out of which at least seven years shall be as a leader. Selection for the various posts of the NCH has been made accordingly.

The various posts of National Commission for Homeopathy (NCH) were advertised in employment News and other leading newspapers across the country to invite applications and all the candidates including Officers from Central Government, Autonomous bodies and private institutions fulfilling the eligibility criteria for the respective posts were eligible to apply. The Appointments Committee of the Cabinet (ACC) has approved the various appointments made under NCH.

(b) No, NCH is having women representatives also. Two of the Ex-officio Members of NCH i.e. Advisor (Homeopathy), Ministry of AYUSH, Govt. of India and Director, North Eastern Institute on Ayurveda and Homeopathy, Shillong are women having long professional experience. All other posts of NCH are also open for both men and women.

(c) Recruitment process for filling up of existing vacancies of Part-time members of NCH and Members of Various Autonomous Boards of NCH is already under Process. For this Central Government had published an advertisement on 16.07.2022 and all the candidates including Central Government employees both men or women even from the cadre of Ministry of Ayush/GDMO(AYUSH/CHS/CGHS) fulfilling the eligibility criteria for the respective posts were eligible to apply. The applications received for the various posts in the NCH will be examined by the Search Committee constituted under the provisions of the Act. After examining all the applications, the Search Committee will submit the report/proposal which will be forwarded to Appointments Committee of the Cabinet for approval.

#### Fund allocation to Uttar Pradesh under AYUSH schemes

#### 646 # Shri Hardwar Dubey:

Will the Minister of *Ayush* be pleased to state:

- (a) the details of funds allocated to Agra district and the State of Uttar Pradesh in general under various AYUSH schemes during the last three years;
- (b) by when Government is expected to release the remaining funds to the State of Uttar Pradesh; and
- (c) whether Government is organizing any special plan or programme to create awareness about Yoga among the public in the country, if so, the details thereof?

#### ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) & (b) Ministry of Ayush is implementing the Centrally Sponsored Scheme of the National AYUSH Mission (NAM) through State/UT Governments including Uttar Pradesh to develop and promote AYUSH systems in the country. Under NAM, funds are being released to the State/UT Governments including Uttar Pradesh against the approved State Annual Action Plans (SAAPs). However, funds are not released district-wise. Under NAM, as per the proposal received from the State Government of Uttar Pradesh, an amount of Rs.32107.27 Lakhs has been released to the State Government of Uttar Pradesh during the last three years for implementation of different activities approved in their SAAPs.

(c)Ministry of Ayush promotes Yoga in the country through its three autonomous bodies namely Morarji Desai National Institute of Yoga (MDNIY), New Delhi, Central Council for Research in Yoga & Naturopathy (CCRYN), New Delhi and National Institute of Naturopathy (NIN), Pune. MDNIY provides various courses for Yoga education and also started a Project Yoga Volunteer Training Programme (36 hours duration) as a part of Azadi ka Amrit Mahotsav activities to train the masses and to create awareness about Yoga among the public. CCRYN is the apex body for research and development in the Yoga and Naturopathy systems. NIN, a premier institute for Naturopathy organizes various activities related to Naturopathy and Yoga.

The Ministry also implements the Central Sector Scheme for Promotion of Information Education and Communication (IEC) in AYUSH to create awareness regarding AYUSH systems of Medicine and Yoga. This aims to reach out to all sections of the population across the country. This scheme provides assistance for organizing National/State Arogya Fairs, Yoga Fests/Utsavs, Ayurveda Parvs etc. Ministry of Ayush also observes International Day of Yoga, every year, on 21<sup>st</sup> June. The Ministry also undertakes multimedia, Print Media Campaigns for creating awareness about AYUSH Systems including Yoga.

Further, the Ministry of Ayush is implementing the operationalization of 12,500 AYUSH Health and Wellness Centers (AHWCs) through State/UT Governments as a component of

the Centrally Sponsored Scheme of National AYUSH Mission (NAM). At these AYUSH HWCs, Yoga is being taught to the public for general health promotion as community based intervention by qualified Yoga Instructors. The State/UT-wise detail of AYUSH Health and Wellness Centers (AHWCs) approved units till 2021-22 are furnished in **Annexure**.

(a) whether any institutional efforts have been made for the production of Ayurvedic and

Herbal medicines in Madhya Pradesh; and

(b) if so, the details thereof?

# ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) & (b) Yes Sir. Ministry of Ayush has implemented Central Sector Scheme AYUSH Oushadhi Gunvatta Evam Uttpadan Samvardhan Yojana (AOGUSY) across the country with financial allocation of Rs 122.00 crores for five years. The components of the Scheme are as under;

A. Strengthening and up-gradation of Ayush Pharmacies and Drug Testing Laboratories to achieve higher standards.

B. Pharmacovigilance of ASU&H drugs including surveillance of misleading advertisements.

C. Strengthening of Central and State regulatory frameworks including Technical Human Resource & Capacity Building programs for Ayush drugs. D. Support for development of standards and accreditation/ certification of Ayush products & materials in collaboration with Bureau of Indian Standards (BIS), Quality Control of India (QCI) and other relevant scientific institutions and industrial R&D centres.

As per the information received from Government of Madhya Pradesh, there are 01 Ayurvedic pharmacy, 03 Ayurvedic College Pharmacy and 01 Cooperative pharmacy of Minor Forest Produce Processing & Research Centre (MFP-PARC), Department of Forest, Government of Madhya Pradesh.

#### Status of the AYUSH Grid Project

649 Shri Sujeet Kumar:

Will the Minister of Ayush be pleased to state:

- (a) whether it is a fact that the AYUSH Grid Project was initiated by the Ministry in 2018 for creating a comprehensive IT backbone for the entire sector and digitalization of the entire AYUSH Sector and it will also lead to transformation in the fields of health care delivery at all levels, including research, education, various health programmes and drug regulations; and
- (b) the details of objective of establishment of AYUSH Grid, its intended institutional structure and proposed functions along with the timelines for implementation of the said project?

#### ANSWER

#### THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

a) Yes, the Ayush Grid (AG) Project is conceptualized by the Ministry of Ayush (MoA) for creating a comprehensive Information Technology (IT) backbone for entire Ayush sector. The AG

platform envisages digitization of service delivery across the six functional areas — Health Services, Education, Research, Drug Administration, Medicinal Plants, and MoA Oversight along with capacity building and media outreach.

b) The proposed objectives, structure, functions along with the timelines of the Ayush Grid Project are as under:

Objectives: i. Enhance access to Ayush services like health services, education, research, etc. in India and at the global level.

ii. Ensure holistic coverage of the Ayush sector by digital solutions.

iii. Increase digital collaboration and exchange of best practices among Ayush stakeholders.

iv. Attaining highest possible level of health & well-being as per National Health Policy 2017.

v. Good Health & Well-being (Ensure healthy lives & promote well-being for all at all ages) in alignment with Sustainable Development Goals (SDG) -3, 2030.

vi. Quality Education (Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all) as per SDG-4 2030

vii. Industry, Innovation and Infrastructure (Build resilient infrastructure, promote inclusive and sustainable industrialization and foster innovation) as per SDG-9 2030

Structure:As per High level Advisory Committee (HLAC) report and Detailed Project Report(DPR), the Ayush Grid follows relevant design principles of India Enterprise Architecture (IndEA) 2.0, Ayushman Bharat Digital Mission (ABDM) Framework and also related principles and standards of National Digital Health Blueprint (NDHB) framework. Ayush Grid Architecture has been designed as a four-layer model, as under:

i. Ayush Core Layer (which also connects to ABDM and other external ecosystems)- Consist of Development of Ayush Core registries, Ayush Core Directories, Ayush Architecture repositories, Ayush Morbidity codes, Ayush Drugs codes etc

ii. Ayush National Layer- Consists of developing all Ayush IT Applications and common reference applications and hand holding for use of applications developed.

iii. Ayush State Layer- State/UT Governments and Private stakeholders shall be given choice of using IT Applications developed under Ayush Grid or to use their own IT systems if available. There will be integration / seamless data exchange and interoperability between various related applications as per the need.

iv. Ayush Citizen Access Layer- Public facing Portals and Mobile apps through which the envisaged services are to be offered to public.

Functions: Digitization of all functionalities and processes in Ayush sector, through applications developed under Ayush Grid with data exchange and interoperability with internal and external applications as per the need.

Timelines : As per the DPR and final approval of the Project.

## "Steps taken to assure quality control of AYUSH drugs"

#### 650 Shri K.C. Venugopal:

Will the Minister of *Ayush* be pleased to state:

(a) the actions that have been taken by Government for the assured quality control of AYUSH drugs in the country;

(b) the details thereof;

(c) whether it is a fact that nine major posts in Central Drug Controller for AYUSH are functioning with temporary staffs; and

(d) if so, whether Government will expedite the recruitment process to fill up nine posts in Central Drugs Standard Control Organisation (CDSCO) on regular basis and the details thereof?

# ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) & (b) As prescribed in Drugs and Cosmetics Act 1940 and Rules 1945 made thereunder, enforcement of the legal provisions pertaining to Quality Control and issuance of drug license of Ayurveda, Siddha, Unani and Homoeopathic drugs, is vested with the State drug Controllers/ State Licensing Authorities appointed by the concerned State/ Union Territory Government. Rule 158-B in the Drugs and Cosmetics Rules, 1945 provides the regulatory guidelines for issue of license to manufacture Ayurvedic, Siddha, Unani medicines and Rule 85 (A to I) in the Drugs and Cosmetics Rules, 1945 provides the regulatory guidelines for issue of license to manufacture Homoeopathic medicines. It is mandatory for the manufacturers to adhere to the prescribed requirements for licensing of manufacturing units & medicines including proof of safety & effectiveness, compliance with the Good

Manufacturing Practices (GMP) as per Schedule T & Schedule M-I of Drugs and Cosmetics Rules, 1945 and quality standards of drugs given in the respective pharmacopoeia.

Ministry of Ayush has taken various steps for assured quality control of AYUSH drugs in the country:

i. Schemes to support Ayurvedic medicines production: Under National Ayush Mission (NAM) from 2014-2021, apart from other services Grant-in-aid were also provided for Strengthening of State Government ASU&H Pharmacies. At present, Central Sector Scheme for Ayush Oushadhi Gunavatta evam Uttpadan Samvardhan Yojana (AOGUSY) has been implemented for the year 2021-2026. The components of the AYUSH Oushadhi Gunvatta Evam Uttpadan Samvardhan Yojana (AOGUSY) Scheme are as under;

A. Strengthening and up-gradation of Ayush Pharmacies and Drug Testing Laboratories to achieve higher standards.

B. Pharmacovigilance of ASU&H drugs including surveillance of misleading advertisements.

C. Strengthening of Central and State regulatory frameworks including Technical Human Resource & Capacity Building programs for Ayush drugs.

D. Support for development of standards and accreditation/ certification of Ayush products & materials in collaboration with Bureau of Indian Standards (BIS), Quality Control of India (QCI) and other relevant scientific institutions and industrial R&D centres.

ii. Pharmacopoeia Commission for Indian Medicine & Homoeopathy (PCIM&H), a subordinate office under Ministry of Ayush lays down Pharmacopeial Standards and Formulary specifications for Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) drugs within the ambit of Drugs & Cosmetics Act, 1940, which serve as official compendia for ascertaining the quality of the drugs included therein. Further, PCIM&H as an appellate drug testing laboratory receives the samples from Government agencies as per Drugs &

Cosmetics Act & Rules there under for ascertaining their quality. In 2021, Pharmacopoeia Commission for Indian Medicine & Homoeopathy (PCIM&H), Ghaziabad a sub-ordinate office of Ministry of Ayush has signed a MoU with American Herbal Pharmacopeia, United States of America (USA) for developing standards of Ayurveda and other Indian systems of medicine on international standards. Further, PCIM&H and Indian Pharmacopoeia Commission (IPC) have signed a MoU for developing "ONE HERB ONE STANDARD".

iii. In addition to the above, for facilitating exports, Ministry of Ayush encourages following certifications of AYUSH products as per details below:-

- Certification of Pharmaceutical Products (CoPP) as per WHO Guidelines for herbal products.
- Quality Certifications Scheme implemented by the Quality Council of India (QCI) for grant of AYUSH Premium mark to Ayurvedic, Siddha and Unani products on the basis of third party evaluation of quality in accordance with the status of compliance to international standards.

iv. 27 State Drug Testing Laboratories have been supported for strengthening their infrastructural and functional capacity. As on date 81 laboratories are approved or licensed under the provisions of Drugs and Cosmetics Rules, 1945 for quality testing of Ayurvedic, Siddha and Unani drugs and raw materials.

v. Pharmacovigilance Centres for Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) Drugs set up in different parts of the country under the Central Scheme of Ministry of Ayush are mandated to monitor and report the misleading advertisements to the respective State Regulatory Authorities. A three tier structure comprising of a National Pharmacovigilance Co-ordination Centre (NPvCC), Intermediary Pharmacovigilance Centres (IPvCs) and Peripheral Pharmacovigilance Centres (PPvCs) is established. All India Institute of Ayurveda (AIIA), New Delhi under Ministry of Ayush is the National Pharmacovigilance Co-ordination Centre (NPvCC) for the implementation of the National Pharmacovigilance program for Ayurveda, Siddha, Unani & Homoeopathy drugs. Objectionable advertisements are being reported to the respective State Licensing Authorities by PPvC at regular intervals.

(c) & (d) Yes Sir. Total 09 posts i.e. 04 posts of Drug Inspectors (01 in each stream-Ayurveda, Siddha, Unani and Homoeopathy); 04 posts of Assistant Drug Controller (01 each for Ayurveda, Siddha, Unani and Homoeopathy) and 01 post of Deputy Drug Controller (ASU&H) has been created for setting up of the Office of the Central AYUSH Drugs Controller in the Ministry of Ayush. Ministry of Ayush has appointed its 09 officers for the additional charge of above mentioned 09 posts in addition to their normal duties in the Ministry of Ayush, without any additional remuneration vide gazette notification S.O. 4562(E) dated 27.09.2022. Ministry of Ayush is in process of filling the 09 posts created for setting up the office of Central Ayush Drugs Controller on regular basis in consultation with Union Public Service Commission (UPSC).

#### Allocation of funds for AYUSH sector in Assam

Will the Minister of *Ayush* be pleased to state:

(a) whether Government has decided to allocate additional funds for enhancing AYUSH sector in Assam or has decided to augment capacity of various existing institutions;

(b) if so, the details thereof;

(c) whether Government has decided to allocate additional funds for Medical Colleges in Assam;

(d) if so, the details thereof;

(e) whether Government has also decided to allot funds for Medical Colleges for research in preventive medicine for COVID-19; and

(f) if so, the details thereof, along with the policy of Government for developing medicine for COVID-19 in homoeopathy?

## ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) & (b) Public Health being a State subject, the primary responsibility to enhance the AYUSH sector in Assam lies with the respective State Governments. However, Government of India is implementing the Centrally Sponsored Scheme of National AYUSH Mission (NAM) through State/UT Governments to develop and promote AYUSH in the country including Assam. The Mission *inter-alia* makes the following provisions for the development and promotion of AYUSH:

(i) AYUSH Health & Wellness Centres

(ii)Co-location of AYUSH facilities at PHCs, CHCs and DHs

(iii)Upgradation of existing standalone Government AYUSH Hospitals

(iv)Upgradation of existing Government/Panchayat/Government aided AYUSH Dispensaries/Construction of building for existing AYUSH Dispensary (Rented/dilapidated accommodation)/Construction of building to establish new AYUSH Dispensary

(v) Setting up of upto 10/30/50 bedded integrated AYUSH Hospitals

(vi)Supply of essential drugs to Government AYUSH Hospitals, Government Dispensaries and Government/Government aided Teaching Institutional AYUSH Hospitals

(vii) AYUSH Public Health Programmes

(viii) Behaviour Change Communication (BCC)

(ix) Mobility support at State and District level

(x) AYUSH Gram

(xi) Establishment of new AYUSH colleges in the States where availability of AYUSH teaching institutions is inadequate in Government Sector

(xii)Infrastructural development of AYUSH Under-Graduate Institutions

(xiii)Infrastructural development of AYUSH Post-Graduate Institutions/ add on PG/ Pharmacy/Para-Medical Courses

Under NAM, a grant-in-aid of Rs. 9428.148 lakhs has been released to State Government of Assam for the implementation of different activities as per the proposals received through State Annual Action Plans (SAAPs).

(c) to (f) Ministry of Health & Family Welfare, Government of India deals with a Centrally Sponsored Scheme for (i) Establishment of new Medical Colleges attached with existing district/referral hospitals; (ii) Up-gradation of existing State Government/Central Government medical colleges to increase MBBS seats in the country; and (iii) Strengthening and up-gradation of State Government Medical colleges for starting new PG disciplines and increasing PG seats. The above schemes are dealt in collaboration with State/UT Governments.

Under the scheme (i) establishment of new medical colleges, 157 medical colleges have been approved in three phases including 05 medical colleges in Assam as per the details given below:-

Further, as per the MoU signed with State Government, any amount in excess of the approved cost is to be borne by the State Government itself. Therefore, there is no provision available for allotment of funds over and above the approved cost.

Further, the Ministry of Ayush issued advisories on AYUSH interventions including Homoeopathy for prophylaxis and management of Covid-19. Director Generals of Research Councils and Directors of National Institutes with their team of experts have prepared guidelines for Registered Practitioners of respective systems of AYUSH including Homoeopathy and the same is vetted by the Inter-disciplinary AYUSH Research and Development Taskforce of the Ministry of Ayush. These guidelines are made available in the public domain to benefit registered AYUSH practitioners including Homoeopathy to help in the management of the COVID-19 pandemic uniformly. (a) & (b) As public health is a State subject, setting up of AYUSH hospitals in different States/UTs of the country including Puducherry comes under the purview of respective State/UT Governments. However, under the Centrally Sponsored Scheme of National AYUSH Mission (NAM), there is a provision for financial assistance for setting up of 10/30/50 bedded integrated AYUSH Hospital. Under NAM, grant-in-aid is being provided to State/UT Governments as per the proposals submitted through State Annual Action Plans (SAAPs). The State/UT-wise list of integrated AYUSH Hospital approved under National AYUSH Mission is furnished as **Annexure**.

(c) & (d) Under the component of setting up of 10/30/50 bedded integrated AYUSH Hospital, provision has also been made for equipping the hospital with essential diagnostic facilities, drugs, equipment and furniture to provide Inpatient Department (IPD) facility.

(a) to (e). Public Health being a State subject, setting up of AYUSHHealth & Wellness Centres (AHWCs) comes under the purview of the respective State/UT Governments. However, under the Centrally Sponsored Scheme of the National AYUSH Mission (NAM), there is a provision for setting up of AHWCs by upgrading existing AYUSHdispensaries / sub health centres.Under NAM, as per the proposals received from State / UT Governments through their State Annual Action Plans (SAAPs),9068units of existing AYUSH dispensaries and sub health centres has been approved to be upgraded as AHWCs and as reported by States/UTsout of the approved Units, 4830AHWCshave been made functional.The State / UT-wise status of approved and functional AYUSH Health and Wellness Centres units are furnished at Annexure.

- (b) whether the Ministry has collected medical books authored in Ancient India and Medieval period;
- (c) if so, whether they are being decoded with the help of modern medical researchers; and
- (d) whether the Ministry will start a journal on traditional medicinal knowledge which will help to collect information and also suppress those who misuse the brand of traditional treatment and medicines?

## ANSWER

#### THE MINISTER OF AYUSH

#### (SHRI SARBANANDA SONOWAL)

- (a) The Ministry of Ayush, Government of India has National Institute of Indian Medical Heritage (NIIMH), Hyderabad as a unit under the Central Council for Research in Ayurvedic Sciences (CCRAS) with a mandate of
  - i. Literary Research and Documentation

- ii. Revival and retrieval of texts from ancient manuscripts and rare books
- Search and Collection of information, descriptive notes, editing and publication of rare medical manuscripts/books on Ayush.
- iv. Documentation
- v. Ayurveda Encyclopedia
- vi. Museum on History of Medicine
- vii. Referral library on Ayush Systems of Medicine and modern medicine.
- viii. Ayush Research Portal
  - ix. CCRAS-Research Management Information System
  - x. National Ayush Morbidity and Standardized Terminologies Electronic (NAMASTE)- Portal.
- xi. Development of W.H.O International Terminologies of Ayurveda, Siddha, Unani.
- xii. Development of SNOMED CT National Extension for Ayurveda, Siddha, Unani.

Apart from this Institute, all five Research Councils under Ministry of Ayush also conducts Literary Research as a part of their research mandate.

- (b) The Central Council for Research in Ayurvedic Sciences, New Delhi does the task of collection, revival and retrieval of ancient manuscripts and books of Ayush systems. The NIIMH, Hyderabad maintains medico-historical library which functions as a referral library. This Library is maintained with two objectives:
  - i. Promotion of knowledge of history of medicine amongst medical students, teachers, interested public.
  - ii. Promotion of Research into the History of medicine in India during the Ancient, Medieval and Modern period and elucidation of the inter-relations between the Evolution of Medicine in India and in other centers of civilization in ancient and medieval times.

The library contains approximately 10384 books (out of which 448 are rare books) on different aspects and branches of History of Medicine and the collection includes several classical texts of Ayush systems and European medicine which includes some early editions. This library possesses 285 Manuscripts (Palm leaf/paper) out of which, 173 belongs to Ayurveda; 106 to Unani System of Medicine and 06 of Siddha system of

medicine. The institute also maintains digital repository of 2700 medical manuscripts and 1335 rare books collected from different manuscript repositories, State Museums, Academic Institutions, Libraries and personal collections across South India, Maharashtra, and Madhya Pradesh. Out of these 2700 digital manuscripts; 1335 belongs to Ayurveda; 542 to Unani; 598 to Siddha; 49 to Yoga and 176 to other topics. Further, 1679 manuscripts/rare books have been digitalized under the project entitled "Survey, Cataloguing and Digitalized inventory of Medical Manuscripts of Eastern India (Orissa, West Bengal and Bihar) and 770 Manuscripts have been digitalized under the project entitled "Survey, Cataloguing and Digitalized inventory of Medical Manuscripts of North-East India" by the CCRAS.

- (c) The Central Council for Research in Ayurvedic Sciences, New Delhi undertakes editing of transliteration, transcription, translation, publication of manuscripts and rare books of ancient and medieval period for wider dissemination and global readership. Similarly, the Central Council for Research in Siddha (CCRS) has also deciphered ancient Siddha literatures originally available in Tamil Prose and translated them to Tamil and English language. The list of books published by CCRAS from ancient manuscripts is placed at Annexure-I.
- (d) Various National Level institutes and Research Councils under Ministry of Ayush publish Journal on regular basis for wider dissemination of research outcomes. The list of various journals published is placed at Annexure II.

Will the Minister of *Ayush* be pleased to state:

(a) whether advertisements of health products are shown on television by resorting to various traditional systems of medicine like Ayurveda, etc. and whether these products also have any approval from the Drug Controller General of India;

(b) whether the use of such products have been shown to have caused health hazards as they have a direct effect on the liver or kidneys and also because most of the products do not have the certification of benefits and safety for human body;

(c) whether Government is planning to frame rules or laws to ban such products; and

(d) if so, by when, and if not, the reasons therefor?

# ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) to (d) As prescribed in Drugs and Cosmetics Act 1940 and Rules 1945 made thereunder, enforcement of the legal provisions pertaining to Quality Control and issuance of drug license of Ayurveda, Siddha, Unani and Homoeopathic drugs, is vested with the State drug Controllers/ State Licensing Authorities appointed by the concerned State/ Union Territory Government.

Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954 and Rules thereunder encompass the provisions for prohibition of misleading advertisements and exaggerated claims of drugs and medicinal substances including AYUSH medicines, which appear in the print and electronic media and Government has taken note thereof. Central Government has notified insertion of Rule 170 in the Drugs & Cosmetics Rules, 1945 on 24<sup>th</sup> December, 2018 specifically for controlling inappropriate advertisements of Ayurvedic, Siddha and Unani medicines.

State/UT Governments are empowered to enforce the provisions of Drugs & Magic Remedies (Objectionable Advertisements) Act, 1954 & Rules there under and Rule 170 of the Drugs & Cosmetics Rules, 1945 pertaining to control and prohibition of misleading advertisements and exaggerated claims of drugs. Accordingly, directives have been issued to the States/UTs for appointing Officers to enter, search any premises or examine or seize any record related to the alleged misleading or improper advertisements and initiate action against the cases of default.

Rule 158-B in the Drugs and Cosmetics Rules, 1945 provides the regulatory guidelines for issue of license to manufacture Ayurvedic, Siddha, Unani medicines which are as follows – (I) For issue licence to the medicine with respect to Ayurvedic, Siddha and Unani, the conditions relating to safety study and the experience or evidence of effectiveness are follows -

Pharmacovigilance Centres for Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) Drugs set up in different parts of the country under the Central Scheme of Ministry of Ayush are mandated to monitor and report the misleading advertisements to the respective State Regulatory Authorities. A three tier structure comprising of a National Pharmacovigilance Co-ordination Centre (NPvCC), Intermediary Pharmacovigilance Centres (IPvCs) and Peripheral Pharmacovigilance Centres (PPvCs) is established. All India Institute of Ayurveda (AIIA), New Delhi under Ministry of Ayush is the National Pharmacovigilance Co-ordination Centre (NPvCC) for the implementation of the National Pharmacovigilance program for Ayurveda, Siddha, Unani & Homoeopathy drugs. Objectionable advertisements are being reported to the respective State Licensing Authorities by PPvC at regular intervals. The identified centers under this program report instances of misleading advertisements to the respective state licensing authorities for suitable action against the defaulters. As per the information received from States/ UTs, no ASU&H product have been reported for causing health hazards.

(a) Sir, the Ministry of Ayush is implementing variousSchemesbut none of them have any provisions for revenue generation.

(b) The Ministry of Ayush has a mandate for formulation of policy and policy issues for development and propagation of Ayush system of Health care. The Ministry is implementing following Schemes including Central Schemes and Centrally sponsored Schemes for development and promotion of Ayush System on both National and Global level:-

i. National Ayush Mission (NAM)

Central Sector schemes:

- i. Scheme for Promotion of Information, Education and Communication(IEC) in Ayush
- ii. Central Sector Scheme for Promotion of International Co-operation inAyush

- v. Setting up of upto 10/30/50 bedded integrated Ayush Hospitals
- vi. Supply of essential drugs/consumables to Government Ayush Hospitals, Government Dispensaries and Government/Government aided Teaching Institutional Ayush Hospitals
- vii. Ayush Public Health Programmes
- viii. Behavior Change Communication (BCC)
  - ix. Mobility support at State and District level
  - x. Ayush Gram
- xi. Establishment of new Ayush colleges in the States where availability of Ayush teaching institutions is inadequate in Government Sector
- xii. Infrastructural development of Ayush Under-Graduate Institutions
- xiii. Infrastructural development of Ayush Post-Graduate Institutions/ add on PG/ Pharmacy/Para-Medical Courses

## 2) Central Sector schemes

# a) Scheme for Promotion of Information, Education and Communication (IEC) in Ayush

Under this scheme Ministry works for popularizing strengths of Ayush systems by rising awareness through outdoor, electronic media including organization of Arogya fairs and supporting seminars and workshops on Ayush systems.

# c) AYURGYAN scheme

This scheme has two components namely

# I. Capacity Building and Continuing Medical Education (CME) in Ayush

The overall structure of the Scheme is aimed to encourage Ayush personnel to undergo need-based professional training and bridge the knowledge gaps. The objectives of the scheme are:

- i. To encourage Ayush professionals to undergo need-based professional orientation and professional skill development in an organized manner.
- ii. To update the professional knowledge of teachers and doctors to adopt good teaching practices and good clinical practices respectively.
- iii. To encourage the use of Information technology and web-based education programmes for widespread dissemination of Ayush developments and updates.

# II. Research and Innovation in Ayush.

The Research and Innovation component (erstwhile Extra Mural Research Scheme) was introduced to tap the potential of medical, scientific and research & development institution, university, organizations for the research needs of Ayush sector, with aim to expand the ambit of research in Ayush systems. Research and Innovation component AYURGYAN Scheme of Ministry of Ayushhas been designed to encourage Research & Development in priority areas based on disease burden in alignment to National Health Programme.

The priority areas of support are fundamental concepts, basic principles, theories of Ayushsystems, standardization/validation of Ayush drugs and new drug development.

Outcomes of the Research Schemehave successfully demonstrated the effectiveness of Ayushsystems and were successful in developing novel technology and are expected to harness the potential of Ayush in the interest of public health delivery

#### d) AYURSWASTHYA Yojana

Main component of AYURSWASTHYA Yojana

#### I. Ayush and Public Health.

The scheme is being implemented with a District/Block/Taluk as a unit for the roll out of authentic classical Ayush interventions with following objectives:-

- i. To promote Ayush intervention for community health care.
- ii. To demonstrate advantages of Ayush health care in public health.
- To support for implementing Sustainable Development Goal-2 (SDG2and Sustainable Development Goal -3 (SDG 3) through integrating Ayushsystem.
- iv. Documentation of the efficacy of Ayush systems through Ayush interventionsin various public health issues which can be taken up in larger scale for implementation in national health programmes.
- v. Promote use of Ayush Interventions in sports medicine for promoting health and fitness of sports persons.
- vi. Promote Ayush therapeutic interventions for treatment of sports related injuries and their rehabilitation.

#### II. Up-gradation of facilities to Centre of Excellence

Objectives under CoEComponent:-

- i. To support establishment of advanced/ specialized Ayush medical health unit in reputed Ayush and Allopathy institutions both in Government and Non Government sector.
- ii. To support creative and innovative proposals for establishment and up-gradation of both functions and facilities of reputed institutions to strengthen competencies of Ayush professionals in Education technology, Research & innovation and such other fields necessary for promotion of Ayush at national as well as internationallevel.
- To support creative and innovative proposals for prestigious organizations whichhave well-established buildings and infrastructure, and wish to work for Ayushsystems to the level of Centre of Excellence.

#### e) AyushOushadhiGunavattaevumUttapadanSamvardhanYojana(AOGUSY)

With the objective to enhance India's manufacturing capabilities and exports of traditional medicines and health promotion products under the initiative of Atmanirbhar Bharat, to facilitate adequate infrastructural & technological upgradation and institutional activities in public and private sector for standardization, quality manufacturing and analytical testing of Ayush drugs & materials, to strengthen regulatory frameworks at Central and State level for effective quality control, safety monitoring and surveillance of misleading advertisements of Ayush drugs and to encourage building up synergies, collaborations and convergent approaches for promoting standards and quality of Ayush drugs & materials.

# f) Central Sector Scheme for "Conservation, Development and Sustainable Management of Medicinal Plants"

The Central Sector Scheme on "Conservation, Development and Sustainable Management of Medicinal Plants" is aimed at providing project based support for the following activities:

- i. In-situ conservation / ex-situ conservation including establishment of nursery.
- Information Education Communication activities like training/Workshops/ Seminars/ Conference etc.

- iii. Research and Development.
- iv. Establishment of Herbal Garden.
- v. Promotion, marketing and trade of medicinal plants produce.

# g) Central Sector Scheme for the Promotion of International Co-operation in AYUSH (IC Scheme)

The Ministry has developed a Central Sector Scheme for the Promotion of International Co-operation in Ayush (IC Scheme) under which the Ministry of Ayush provides support to Indian Ayush Manufacturers/ Ayush Service providers to give boost to the export of Ayush products & amp; services; facilitates the International promotion, development and recognition of Ayush system of medicine; foster interaction of stakeholders and market development of Ayush at international level; promote academics and research through the establishment of Ayush Academic Chairs in foreign countries and holding training workshop/symposiums for promoting and strengthening awareness and interest about Ayush Systems of Medicine at international level.

The Ministry of Ayush has taken the following steps towards the promotion of international collaborations and investments towards the promotion of Ayurveda at the global level:

- i. Ministry has signed 24 Country to Country MoUs for Cooperation in field of Traditional Medicine and Homoeopathy with foreign nations.
- 40 MoUs have been signed with international institutes for undertakingCollaborative Research / Academic collaboration.
- 15 MoUs have been signed with international institutes for setting up of AYUSHAcademic Chairs in foreign nations.
- iv. Ministry of Ayush has provided support for the establishment of 38 AyushInformation Cells in 34 foreign nations.
- v. Ministry of Ayush under its International Fellowship/Scholarship Programmeoffers scholarships to foreign nationals for undertaking Ayush courses inrecognized Ayush institutions in India.
- vi. Ministry of Ayush and WHO have signed an agreement to establish WHO-GCTMin Jamnagar, Gujarat, the ground-breaking Ceremony of which was attended bythe Hon'ble Prime Minister of India, Director General of WHO and otheresteemed

dignitaries on 19.04.2022 in Jamnagar, Gujarat. This Centre aims toprovide support to implement WHO's traditional medicine strategy (2014-23) andto support nations in developing policies & amp; action plans to strengthen the role offraditional medicine as part of their journey to universal health coverage.

- vii. Ministry of Ayush, Government of India in consultation with Department ofCommerce has supported to establish Ayush Export Promotion Council(AEPC) to promote the export of Ayush products/ medicines as well asAyush services. This was launched by the Hon'ble Prime Minister on 20<sup>th</sup> April 2022 at Global Ayush Innovation and Investment Summit inGandhinagar (Gujarat).
- viii. The Global Ayush investment and Innovation Summit, 2022 was a distinctive effort by the Government of India to attract the world's attention to India's ancient wisdom and traditional knowledge, and capitalize on it to pave the way for a sustainable future. This Summit was inaugurated by the Hon'ble Prime Minister of India in presence of Director General of WHO and otheresteemed dignitaries on 20.04.2022 in Jamnagar, Gujarat. It has concluded on a high note, with Ayush sector witnessing Letter of Intents (LoIs) over Rs. 9,000 crore in just three days. During the summit, more than 70 Memorandum of Understanding (MoUs) were signed between Countries, prestigious research institutes, the farmer groups and industry.

#### ANSWER THE MINISTEROF AYUSH (SHRI SARBANANDA SONOWAL)

(c) Ministry of Ayush is implementing the operationalization of AYUSH Health and Wellness Centres (AHWCs) under Ayushman Bharat as a component of the Centrally Sponsored Scheme of National AYUSH Mission (NAM) through State/UT Governments with an objective to establish a holistic wellness model based on AYUSH principles and practices. Under NAM, as per the proposals received from State / UT Governments through their State Annual Action Plans (SAAPs),9068units of existing AYUSH dispensaries and sub health centres has been approved to be upgraded as AHWCsand as reported by States/UTsout of the approved Units,4830AHWCshave been made functional. The State / UT-wise status of approved and functional AYUSH Health and Wellness Centresunits are furnished at **Annexure**. As far as the data of beneficiaries who are availing different type of services throughAHWCs are available with State or UT Governmentsand is not being maintained by Government of India. Further, at the functional AHWCs the expanded services are being provided having the nature of preventive promotive, curative and rehabilitative healthcare.

(d) & (c) As per the provision NAM guideline, AYUSH dispensaries and sub health centres are being supported to be upgraded as AYUSH Health and Wellness Centres which is also having the provision for establishment of herbal garden. Accordingly, as per the proposalsreceived from State/UT Governments through SAAPs during the time of approval of AHWCs activity for establishment of herbal garden is also being supported and States/UTs are taking appropriate steps for establishment of herbal garden in approved AHWCs.

In addition to this it is also informed that the satellite Centre of National Institute of Ayurveda – Jaipur, is being established at Panchkula (Haryana).

c) &d) Public Health being a State subject, setting up of Ayush Medical Colleges in the country comes under the purview of respective State/UT Governments. However, under Centrally Sponsored Scheme of National AYUSH Mission (NAM), there is provision of financial assistance for establishment of new AYUSH Colleges in the States where availability of Ayush teaching institutions is inadequate in Government Sector. State/UT Governments may avail eligible financial assistance by projecting the same through State Annual Action Plans (SAAPs) as per the provisions of NAM guidelines. Further, under NAM, Ministry of Ayush has approved 13 units of New Educational Institutions as per the proposals received from State/UT Governments. The State/UT wise/stream wise list of approved New Educational Institutions is furnished at **Annexure-II**.

e) & f) At present the Central Government has not askedany State Government to provide free landfor setting up of AYUSH Medical Colleges.

Will the Minister of *Ayush* be pleased to state:

(a) whether Government has recognised the indigenous medicines of AYUSH for the treatment and cure for various types of cancers, liver and kidney ailments;

(b) if so, the details thereof and the current list of approved AYUSH medicines;

(c) whether Government has taken adequate measures to provide approval for some life saving medicines; and

(d) if so, the detailed list of AYUSH medicines registered for approval, got approved, rejected and pending for approval in the last five years?

# ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) and (b) Yes Sir, Ministry of Ayush, Government of India has recognized the indigenous medicines of Ayush systems for the treatment for various types ailments including Cancer, Liver and Kidney ailments.

v. Central Council for Research in Ayurvedic Sciences (CCRAS) under Ministry of Ayush has undertaken clinical studies in improving quality of life in cancer patients and in high grade serous epithelial ovarian

cancer at first serological relapse besides documentation of Cancer treatment practices. Further, CCRAS has also undertaken various clinical studies in the field of Cancer, Liver and kidney diseases. The details are at **Annexure -I**.

C.C.R.A.S and Office of Cancer Complementary and Alternative Medicine (OCCAM), National Cancer Institute (NCI), National Institutes of Health (NIH), United States of America (USA) has also signed Letter of Intent (LoI) on 22.10.2020 and announced during third India-US Ministerial Dialogue held on 27.10.2020 for cooperation in the field of Ayurveda and Cancer Research. Further, C.C.R.A.S has entered into a MoU with Tata Memorial Centre, Department of Atomic Energy Mumbai for cooperation in the field of Ayurveda and integrative Oncology /Cancer research on 17<sup>th</sup> May 2022.

- vi. All India Institute of Ayurveda (AIIA), New Delhi under Ministry of Ayush is running specialty clinic in Nephrology, Integrative Cancer Care & Gastrointestinal disorders and using the classical Ayurveda preparations for managing these cases, based on the principles of Ayurveda. AllA and All India Institute of Medical Science (AIIMS)- National Cancer Institute (NCI), Jhajjar has signed MoU on 29<sup>th</sup> January 2022 to collaborate on Establishment of Centre of Ayurveda and Integrative Oncology at AIIMS, Jhajjar. AllA has also entered in to a MoU with National Institute of Cancer Prevention and Research, Noida.
- vii. Central Council for Research in Unani Medicine (C.C.R.U.M.) under Ministry of Ayush had initiated a project on cervical erosion in collaboration with National Institute of Cancer Prevention and Research (NICPR), Noida (ICMR). Further, one in-vitro study on liver cancer has been undertaken in collaboration with Amity Institute, Noida.

Ministry of Ayush has published National List of Essential AYUSH Medicines (NLEAM) in January, 2022. It comprises of essential Ayurveda, Unani, Siddha and Homoeopathic medicines along with their reference text, main disease indications, dose, precaution/ contraindication.

(c) and (d) There is no separate category of 'life saving medicines' for Ayush system of medicine.

## THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) The 'Centre of Excellence scheme' is an erstwhile Central Sector Scheme of the Ministry of Ayush. Currently, the Ministry of Ayush is running a Central Sector Scheme namely, AYURSWASTHYA Yojana with two components (i) AYUSH and Public Health (PHI) and (ii) Centre of Excellence (CoE) from the Financial Year 2021-22 by merging two erstwhile schemes of this Ministry namely (i) Central Sector Scheme of Grant-in-Aid for Promotion of AYUSH Intervention in Public Health Initiatives (PHI) and (ii) Central Sector Scheme for assistance to AYUSH organizations (Government / Non-Government Non-Profit) engaged in AYUSH Education/ Drug Development & Research / Clinical Research etc. for upgradation to Centre of Excellence (CoE).

Under the Centre of Excellence component of AYURSWASTHYA Yojana, financial assistance is provided to eligible individual organizations/institutes for establishing and upgrading their functions & facilities and/or for research & development activities in AYUSH. The objectives of the Centre of Excellence component of AYURSWASTHYAYojana are as under:-

i. To support establishment of advanced/ specialized AYUSH medical health unit in reputed AYUSH and Allopathic institutions both in Government and Non-Government sector.

ii. To support creative and innovative proposals for establishment and upgradation of both functions and facilities of reputed institutions to strengthen competencies of AYUSH professionals in education technology, research & innovation and such other fields necessary for promotion of AYUSH at national as well as international level.

iii. To support creative and innovative proposals for prestigious organizations which have well-established buildings and infrastructure, and wish to work for AYUSH systems to the level of Centre of Excellence.

The maximum admissible financial assistance under the Centre of Excellence component of AYURSWASTHYA Yojana, to an organization/institute is Rs.10.00 crores for maximum period of three years.

(b) The projects are sanctioned and funds are released directly to the eligible individual organizations/institutes based on the merit of the proposals received from them, under the Centre of Excellence component of AYURSWASTHYA Yojana. There is no provision for State/UT-wise sanction/allocation of funds under the Centre of Excellence component of AYURSWASTHYA Yojana and under erstwhile Centre of Excellence scheme also. The details of the organizations/institutes supported under the Centre of Excellence component AYURSWASTHYA Yojana and erstwhile Centre of Excellence scheme during last three years is at **Annexure-I**.

(c) The wider aspect of health care services i.e. preventive, promotive, curative and palliative health care services are provided by the grantee organizations/institutions under the erstwhile Centre of Excellence scheme and Centre of Excellence component of AYURSWASTHYA Yojana all over the country as per the objectives of the projects. These services are provided to the public including Economical Weaker Section of the society as per scheme guidelines. Special attentions are provided for quality improvement of these health care services also.

(d) No organization/institute of Puducherry is supported under erstwhile Centre of Excellence scheme and Centre of Excellence component of AYURSWASTHYA Yojana. Further, no proposals were received under the Centre of Excellence component of AYURSWASTHYA Yojana from the UT of Puducherry.

(e) Yes, under Centre of Excellence component of AYURSWASTHYA Yojana, there is provision to support AYUSH institutions/organizations for their up-gradation to the level of Centre of Excellence.

Ministry of Ayush consider project proposals for upgradation of AYUSH institutions, whenever received from the eligible organizations/institutes from all over the country including Puducherry, based on the merit of the proposal, as per the provisions of the Scheme guidelines and as per the availability of funds.

- (b) if so, the details of the farmers who have been given subsidy, district-wise; and
- (c) whether the said subsidy could be given on the use of mortgaged land also?

#### ANSWER

# THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

a) No, Madam. Presently, National Medicinal Plants Board, Ministry of Ayush, is not supporting any subsidy for the cultivation of medicinal plants under the National Ayush Mission Scheme.

However, in the past, Ministry of Ayush, Government of India had implemented Centrally Sponsored Scheme of National Ayush Mission (NAM) to provide the subsidy for cultivation of medicinal plants from the financial year 2015-16 to 2020-21. Under the Medicinal Plants component of the National Ayush Mission (NAM) scheme, subsidy @30%, 50% and 75% of cultivation cost was provided for cultivation of 140 prioritized medicinal plants species to the farmers through State Implementing Agencies. As per the scheme guidelines, the support was provided for:

- (**xxv**) Cultivation of prioritized medicinal plants on farmer's land.
- (XXVI) Establishment of nurseries with backward linkages for raising and supply of quality planting material.
- (XXVII) Post-harvest management with forwarding linkages.
- (XXVIII) Primary processing, marketing infrastructure etc.

b) Ministry of Ayush had supported 648 farmers through State Medicinal Plants Board (SMPB), Himachal Pradesh for cultivation of medicinal plants in Himachal Pradesh under medicinal plants component of National Ayush Mission scheme from the financial year 2015-16 to 2020-21. The District-wise information is given below:
